## Handling Procedures

1. Open vial according to enclosed instructions.

- 2. Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
- 5. Incubate the tubes and plate at 37°C for 24-48 hours.

#### Notes

This strain was formerly identified as *Salmonella choleraesuis* subsp. *arizonae* and initially deposited as *Arizona arizonae*.
