For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Growth Conditions

Medium:

ATCC Medium 0196: Yeast malt extract medium ISP #2

Temperature: 26°C

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of medium #196 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a second tube of broth, #196 agar slant and/or plate.
5. Incubate the tubes and plate at 26°C for 2 weeks.

Notes

On #196 agar, colonies are circular, entire, velvety, and convex; with white aerial mycelium. The substrate mycelium is a yellow-brown color.
