ATCC Medium 3: Nutrient agar or nutrient broth

**Temperature:** 45°C

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
  5. Incubate all tubes and plate at 45°C. Growth will be evident in 3 to 5 days.

**Notes**

This strain does not produce aerial mycelium or spores readily. Growth is slow (up to 3 weeks) when incubated at 30°C and no growth occurs at incubation temperatures below 30°C. Vegetative growth on #3 is green in color, aerial growth appears bluish.
