Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

**Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #1395 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #90 agar slant and/or plate

of #173.

5. Incubate the tubes and plate at 37°C for at least one week.

Colonies on #173 agar are creamy, opaque, glistening, and smooth.
