Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Temperature: 37°C

Handling Procedures

- 1. Open vial according to the enclosed instructions.**
- 2. Using a single tube of ISP #1 broth (5 to 6 ml), withdraw approximately 0.5 ml to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.**
- 3. Aseptically transfer this aliquot back into the broth tube and mix well.**
- 4. Use several drops of the cell suspension to inoculate a second tube of broth, a**

slant and/or a plate.

5. Incubate all tubes and plate at 37°C for 48-72 hours.

Notes

Vegetative cells have an irregular edge and a smooth, heaped folded center.

Pigmentation of the vegetative cells is medium to dark pink on ATCC #196, ISP 2 medium. The strain does not produce aerial mycelium or a soluble pigment.
