## Handling Procedures

1. Open vial according to enclosed instructions.
2. From a single tube of #4 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
4. You may use several drops of the suspension to inoculate a second tube of broth, a slant, and/or plate. However, it is advisable to establish good growth in the

primary tube (24-48 hours) before making subsequent transfers.

5. Incubate all tubes and plate in a 37°C incubator. Growth should occur in 24-48 hours.

## Notes

An alternative medium which supports good growth is ATCC Medium #260, Trypticase Soy Agar (BBL 11043) with 5% defibrinated sheep blood.
