ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

- 1. Open vial.
- 2. Under anaerobic conditions, withdraw 0.5 mL of #2107 broth from a single test tube (5 to 6 mL), with a Pasteur or 1.0 mL pipette. Rehydrate the entire pellet.

- 3. Aseptically transfer this aliquot back into the broth tube. Mix well. Additional tubes of broth may be inoculated with 0.5 mL each from the suspension and 0.2 mL may be inoculated onto a slant. Streak several blood plates for colony morphology and purity.
- 4. Incubate the tubes and plate under anaerobic conditions at 37°C for 24 to 48 hours. Incubate the purity plate aerobically at 37°C. Turbid growth is evident in the broth at 24 to 48 hours.

#### ANAEROBIC CONDITIONS:

Anaerobic conditions for transfer may be obtained by either of the following:

- Use of an anaerobic gas chamber.
- Placement of test tubes under a gassing cannula system hooked to anaerobic gas.

Anaerobic conditions for incubation may be obtained by any of the following:

- Loose screw caps on test tubes in anaerobic chamber.
- Loose screw caps on test tubes in an activated anaerobic gas pack jar.
- Use of sterile butyl rubber stoppers on test tubes so that an anaerobic gas headspace is retained.

#### Notes

Anaerobe Systems PRAS Brucella Blood Plates (AS-111 or AS-141) can be used to analyze colony morphology and purity. No growth should occur on the aerobic blood plate.
