For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Growth Conditions**

Medium: ATCC Medium 416: Lactobacilli MRS Agar/Broth Temperature: 30°C Atmosphere: 95% Air, 5% CO<sub>2</sub>

#### Handling Procedures

- 1. Open vial.
- Using a single tube of #416 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.

- 4. Use several drops of the suspension to inoculate a #416 agar slant and/or plate.
- 5. Incubate the tubes and plate at 30°C in an atmosphere of 5%  $\rm CO_2$  for 24 hours.

#### Notes

Growth on #416 plates yields pulvinate colonies with entire margins and an opaque intrastructure. Best growth obtained when incubated in 5% CO<sub>2</sub>.
