## Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. From a single tube of #1877 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well.
- 4. Use several drops of this suspension to inoculate an additional broth tube, one or



two #172 agar slants and/or a plate.

5. Incubate the tubes and plate at 26°C for 7 to 14 days.

#### Notes

Circular orange colonies become pulvinate and then folded or wrinkled with time. Dark brown pigmentation develops as sporulation occurs. Spores occur singly and are circular and non-motile.
