Description

Bacillus sp. strain E601 is a whole-genome sequence bacterium with applications as an ionizing radiation-sterilization control. This strain is recommended by ATCC for use in the tests described in U.S. Pharmacopeia where only the taxon is specified.

Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #18 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #18 agar slant and/or plate.

5. Incubate the tubes and plate at 30°C for 24 hours.

Notes

On #18 plates, two colony types are observed: a) translucent, erose, irregular, raised, dull; and b) opaque, smooth, entire, glistening, circular, and raised.
