Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

#### **Medium:**

ATCC Medium 797: Flavobacterium M 1 agar

**Temperature:** 30°C

### **Handling Procedures**

1. Open vial according to enclosed instructions.
2. Using a single tube of #797 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.

4. Use several drops of the suspension to inoculate an additional broth tube, a #797 agar slant and/or a plate.
  5. Incubate all tubes and plate at 30°C for 24 hours.

## **Notes**

Colonies on #797 plates are entire, glistening, smooth, golden yellow, mucoid, low convex, and circular.
