Handling Procedures

- 1. Open vial according to enclosed instructions.
- From a single tube of #416 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the pellet.
- 3. Aseptically transfer the rehydrated pellet back into the broth tube. Mix well
- 4. Use several drops of this suspension to inoculate a second tube of broth, a slant and/or a plate.

5. Incubate tubes and plate at 37°C for 24-48 hours in an atmosphere of 5% CO₂. Loosen the screw caps of tubes while incubation period.
