#### Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #3 broth (5 to 6 mL), withdraw approximately 0.5 to 1.0 mL with a Pasteur or 1.0 mL pipette and use to rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
- 5. Incubate the tubes and plate at  $37^{o}\text{C}$  for 24 hours.

#### Notes

On #3 plates, colonies are entire, smooth, glistening, and cream-colored.
