Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

3. Aseptically transfer this aliquot back into the broth tube. A slant and a prereduced blood plate may also be inoculated with 0.1 ml each of the cell suspension.

An aerobic blood plate may also be streaked to check for purity.

4. Incubate tubes and plate under anaerobic conditions at 37°C. Incubate blood plate aerobically at 37°C.

5. Within 24 to 48 hours, growth should be evident by small, fine granular turbidity in the broth and smooth colonies on the anaerobic agar surface. No growth should occur on the blood agar plate incubated aerobically.
