### **Handling Procedures**

- 1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
- 2. Rehydrate the entire pellet with approximately 0.5 mL of #44 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #44 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
- 3. Use several drops of the primary broth tube to inoculate a #814 plate and/or #814 agar slant.
- 4. Incubate at 37°C for 24 to 48 hours in an atmosphere of 5% CO<sub>2</sub>.

#### Notes

ATCC® Medium 260: Trypticase soy agar/broth with defibrinated sheep blood from Medium can be used as an alternative.
