- Rehydrate the entire pellet with approximately 0.5 mL of #1100 broth.
 Aseptically transfer the entire contents to a 5-6 mL tube of #1100 broth.
 Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.
- 3. Use several drops of the primary broth tube to inoculate a #1100 plate and/or #1100 agar slant.
- 4. Incubate at 27°C for 48 hours.
