Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #1396 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #1396 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
3. Use several drops of the primary broth tube to inoculate a #1396 plate and/or #1396 agar slant.
4. Incubate at 37°C for 24-48 hours.
