## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1395 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #90 agar slant.

5. Incubate the tube and slant at 37°C for at least 3 weeks.

## Notes

Colonies on #90 plates are buff-colored, opaque, convex, rough, and undulate.
