Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #814 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #814 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary

- broth tube to these secondary broth tubes.
3. Use several drops of the primary broth tube to inoculate a #814 plate and/or #814 agar slant.
 4. Incubate at 37°C for 24 to 48 hours in an atmosphere of 5% CO₂.

Notes

Brain Heart Infusion (BD 237500) can be used to rehydrate vial contents if #814 broth is not available, but it will not support growth as well as the GC broth. Additional information on this culture is available on the ATCC® web site at www.atcc.org.
