Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #2 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #2 broth. Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.

3. Use several drops of the primary broth tube to inoculate a #2 plate and/or #2 agar slant.
 4. Incubate at 15°C for 3-7 days.

Notes

It is recommended to allow this strain to establish growth first in the broth tubes for 3-4 days before transferring to agar plates and/or slant tubes. Growth on plates may take up to 7 days.

Note: Use chilled media for rehydration or the cells may be damaged. Place tubes at the proper temperature immediately. Avoid temperatures of 20°C or above.
