## Handling Procedures

1. Open vial. Visit [www.atcc.org](http://www.atcc.org) for instructions.
  2. Rehydrate the entire pellet with approximately 0.25 mL of #1395 broth.  
Aseptically transfer the entire contents to a 5-6 mL tube of #1395 broth.  
Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
  3. Use several drops of the primary broth tube to inoculate a #0173 plate and/or #0090 agar slant.
  4. Incubate at 37°C for 1-2 weeks.
