Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #1993 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well. Use several drops of the suspension to inoculate an additional broth tube, a #1993 agar slant and/or a plate.

4. Incubate all tubes and plate at 30°C for 24 hours.

Notes

Colonies on #1993 agar are small, round, smooth, convex, entire, and yellow.
