- 2. Rehydrate the entire pellet with approximately 0.5 mL of #432 broth.

 Aseptically transfer the entire contents to a 5-6 mL tube of #432 broth.

 Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary tubes.
- 3. Use several drops of the primary broth tube to inoculate a #432 plate and/or #432 agar slant.
- 4. Incubate at 26°C for 4 to 7 days.
