Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

- Use several drops of the primary broth tube to inoculate a #73 plate and/or #73 agar slant.
- 4. Incubate at 28°C for 24-48 hours.
