## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #784 broth (5 to 6 ml), aseptically transfer 0.5 to 1.0 ml to the vial and rehydrate the pellet.
3. Aseptically transfer this aliquot back into the broth tube and mix well.

4. Use several drops of the suspension to inoculate agar slant(s) and or plate(s).

## Notes

Strain is able to grow on ATCC Medium #3, Nutrient Agar (Difco 0001) or Nutrient Broth (Difco 0003).

Microscopic examination shows the cells to be small rods in singles and pairs that are motile. They stain Gram negative.

The culture is pink under all conditions tested.
