Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures

- 1. Open vial according to enclosed instructions.
- Using a single tube of #1099 broth (5 to 6 ml), withdraw approximately 0.5 to
 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #1099 agar slant and/or plate.

5. Incubate the tubes and plate at 37°C for 4-7 days.

Notes

Two colony types are observed on # 1099 agar: (1) Small, circular, entire, slightly peaked and (2) Larger, circular, entire, and slightly peaked. Additional information on this culture is available on the ATCC[®] web site at <u>www.atcc.org</u>.
