Handling Procedures

- 1. Open vial according to enclosed instructions.
- 2. Using a single tube of #2258 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate the entire pellet.
- 3. Aseptically transfer this aliquot back into the broth tube. Mix well.
- 4. Use several drops of the suspension to inoculate a #2258 agar slant and/or plate.

Colonies on #2258 agar are entire, glistening, circular, cream-yellow, and convex. Cells are gram-negative rods.
