Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

## Handling Procedures

1. Open vial according to enclosed instructions.
2. Using a single tube of #3 broth (5 to 6 ml), withdraw approximately 0.5 to 1.0 ml with a Pasteur or 1.0 ml pipette. Rehydrate pellet.
3. Aseptically transfer this aliquot back into the broth tube. Mix well.
4. Use several drops of the suspension to inoculate a #3 agar slant and/or plate.
5. Incubate the tubes and plate at 37°C for 2-3 days.

## Notes

Colonies on #3 agar appear small, circular, low convex, entire, glistening, and cream-colored.

Cells in #3 broth are motile rods.
