Lactiplantibacillus plantarum strain NCIMB 8826 [Hayward 3A, WCFS1] is a whole-genome sequenced bacterium that was isolated in 2002 from human saliva.

Handling Procedures

1. Open vial according to enclosed instructions or visit www.atcc.org for instructions.
2. Rehydrate the entire pellet with approximately 0.5 mL of #416 broth. Aseptically transfer the entire contents to a 5-6 mL tube of #416 broth.

Additional test tubes can be inoculated by transferring 0.5 mL of the primary broth tube to these secondary broth tubes.

3. Use several drops of the primary broth tube to inoculate a #416 plate and/or #416 agar slant.
4. Incubate at 37°C for 24 to 48 hours in an atmosphere of 5% CO₂.
