# Description

U-937 NFkB-LUC2 is a luciferase reporter-labeled cell line that endogenously expresses a high level of SIRPA. This reporter cell line can be used in cell-based assays for monitoring the activity of NFkB signaling pathways.

ATCC highly recommends that appropriate personal protective equipment is always used when handling vials. For cultures that require storage in liquid nitrogen, it is important to note that some vials may leak when submersed in liquid nitrogen and will slowly fill with liquid nitrogen. Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

### **Handling Procedures**

#### **Unpacking and storage instructions:**

1. Check all containers for leakage or breakage.

2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.

**Complete medium:** The base medium for this cell line is ATCC-formulated RPMI-1640 Medium (ATCC 30-2001). To make the complete growth medium, add the following components to the base medium: fetal bovine serum (ATCC 30-2020) to a final concentration of 10% and puromycin to a final concentration of 0.5  $\mu$ g/mL.

#### **Handling Procedure:**

To ensure the highest level of viability, thaw the vial and initiate the culture as soon as possible upon receipt. If upon arrival, continued storage of the frozen culture is necessary, it should be stored in liquid nitrogen vapor phase and not at -70°C. Storage at -70°C will result in loss of viability.

- 1. Thaw the vial by gentle agitation in a 37°C water bath. To reduce the possibility of contamination, keep the O-ring and cap out of the water. Thawing should be rapid (approximately 2 minutes).
- 2. Remove the vial from the water bath as soon as the contents are thawed and decontaminate by dipping in or spraying with 70% ethanol. All of the operations from this point on should be carried out under strict aseptic conditions.
  - It is recommended that the cryoprotective agent be removed immediately. Transfer the vial contents to a centrifuge tube containing 9.0 mL complete culture medium and spin at approximately 150 to 400 x g for 8 to 12 minutes.
- 3. Resuspend cell pellet with the recommended complete medium (see the specific batch information for the culture recommended dilution ratio) and dispense into a 25 cm<sup>2</sup> or a 75 cm<sup>2</sup> culture flask. It is important to avoid excessive alkalinity of the medium during recovery of the cells. It is suggested that, prior to the addition of the vial contents, the culture vessel containing the complete growth medium be placed into the incubator for at least 15 minutes to allow the medium to reach its normal pH (7.0 to 7.6)
- 4. Incubate the culture at 37°C in a suitable incubator. A 5% CO<sub>2</sub> in air atmosphere is recommended if using the medium described on this product sheet.

#### **Subculturing procedure:**

Cultures can be maintained by addition or replacement of fresh medium.

Alternatively, cultures can be established by centrifugation with subsequent

resuspension at 2-3 X  $10^5$  viable cells/mL. Maintain the cell density from 1 X  $10^5$  to 2 X  $10^6$  cells/mL. Corning® T-75 flasks (catalog #431464) are recommended for subculturing this product.

**Medium Renewal:** Add fresh medium every 2 to 3 days (depending on cell density). **Reagents for cryopreservation:** Complete growth medium supplemented with 5% (v/v) DMSO (ATCC 4-X)
