This pair of product includes two plasmids: pENTR\_L1L2\_PhlF-VP64 contains an ATCC® synthetic activator, PhlF-VP64, (ATCC SB-1099®) and pENTR\_L4R1\_PhlF-pCYC1MIN contains an ATCC® synthetic promoter, PhlF-CYC1MIN, (ATCC SB1060®). They are two of DNA parts in the ATCC® Synthetic Biology Yeast Tool Kit for building gene circuits in yeast, Saccharomyces cerevisiae. # Handling Procedures

Before opening the vial, centrifuge at 6,000 x g for 30 seconds. Add 30  $\mu$ L of Molecular Grade Water and incubate the vial at 4°C overnight to dissolve the DNA. Each vial contains 2-3  $\mu$ g plasmid DNA (measured by PicoGreen® dsDNA quantitation assay).
