- 2. Gently mix the sample to ensure an even distribution of material.
- 3. Briefly centrifuge the tube before opening to ensure all liquid is at the bottom.

#### Notes

RNA is easily degraded. Take extra precautions against contamination by using new gloves and clean lab coats when working with RNA. Use only RNase-free lab materials when handling this product. Vortexing can damage the RNA. Gentle pipetting is highly recommended. Aliquoting is highly recommended to avoid multiple freezethaws, which can damage the RNA.
